




Established Alfalfa

Chateau[®] EZ Herbicide—A Proven, Long-Lasting Preemergence Herbicide for Established Alfalfa

Alfalfa growers should start strong with a residual herbicide like Chateau[®] EZ Herbicide. *Chateau* EZ makes an excellent residual partner with glyphosate, Gramoxone[®] and other postemergence herbicides.

- Broad Spectrum: controls more than 90 tough weeds in alfalfa including groundsel, chickweed, shepherd's-purse, nettle and annual bluegrass

- Weather-Ready: remains active until 1/4-inch rainfall or irrigation releases its activity



How To Use

Rate	 4 fl oz/A Do not apply more than 4 fl oz per acre per application Do not make more than 2 applications per acre per year Do not apply more than 8 fl oz per acre per year
Timing	 Apply after hay removal and before 6 inches of growth occurs For best results, apply in fall before weeds emerge Chateau EZ requires at least ¼ inch of irrigation or rainfall for activation





How To Use continued

Method	Ground or air. For best results, apply with ground spray equipment.
Spray Volume	10–30 gallons/A by ground
Adjuvant	Only apply with an adjuvant or tank mix with products formulated as an emulsifiable concentrate when targeting control of emerged weeds. Crop burn and/or stunting should be expected and accepted if <i>Chateau</i> EZ is used with an adjuvant, a tank mix partner formulated as an emulsifiable concentrate or a tank mix partner formulated with an adjuvant.
REI / PHI	12 hours / 25 days

Other Important Information

- > Alfalfa is considered established if it has been cut at least one time
- Do not apply within 25 days of harvest or grazing
- Wait at least 60 days between applications
- Not for use on intended mixed alfalfa-grass stands
- Chateau EZ may temporarily burn alfalfa leaves and stems
- Tank mix with Gramoxone and/or Velpar to burn down winter annuals prior to or during winter dormant period
- Clean spray tank immediately after using *Chateau* EZ. See label for details.
- > Signal word: Caution. No respirator required.
