How To Use

Rate	6–12 fl oz/A (up to 24 fl oz/A per year). For best results, apply with a burndown herbicide.
Burn Down	Use the highest label rate of Roundup®, Cheetah®, Rely®, Treevix® or Gramoxone®
Timing	Apply after final harvest in fall and before bud break in the spring. For best results, apply in the fall before winter rains and prior to second flush of weed emergence in late winter in California. Apply twice per season for maximum residual weed control.
Method	Apply a uniform broadcast spray. Direct spray to the orchard floor and the base of tree trunks. Ensure uniform coverage across the entire berm.
Spray Volume	Minimum of 15 gallons of spray solution per acre
Adjuvant	Per recommendation of tank mix partner
REI / PHI	12 hours / 60 days

Other Important Information—See Label for Complete Information

- Other tree nuts on label: beechnut, Brazil nut, butternut, cashew, chestnut, chinquapin, coconut, ginkgo, heartnut, hickory nut, macadamia nut, pili nut, pine nut and tropical almond
- Do not apply to trees established less than one year, unless protected from spray contact
- ▶ Apply a maximum of 6 fl oz/A per application on any soil that has more than 80% sand plus gravel content if trees are less than 3 years of age
- ▶ Follow instructions for spray tank clean out immediately after use. See label for details.
- In certain areas in Merced, San Joaquin and Stanislaus counties of California, almond growers must follow specific timing, soil type, pH and moisture requirements. See label for details.
