How To Use

Rate	8–22.5 fl oz/A
Timing	Repeat application at 7- to 14-day intervals
Method	Apply this product by ground, drip or aerial applications in appropriate water volumes to ensure good coverage
Spray Volume	100–300 gal/A
REI / PHI	4 hours / 0 days

Other Important Information

- ▶ Apply preventatively before pests and diseases develop
- ▶ For best results, buffer the tank water/mixture to a pH of 5.5
- ▶ Do not use with highly alkaline materials
- ▶ Pre-test tank mix on a few plants to observe for any phytotoxicity
- ▶ *Debug Tres* is toxic to fish and aquatic invertebrates—drift or runoff may be hazardous to aquatic organisms in water adjacent to treated areas
